Message from Board Chair & Chief Executive Officer



Dear Friends & Supporters:

We are committed to building a more equitable community. For too many of our neighbors, economic, housing, and food security are often out of reach. At Legal Services, we **challenge the legal structures that perpetuate these inequities**. In 2023, years of planning, hard work, and focus on high-quality advocacy came together and resulted in incredible successes for our program, clients, and community.

Last year we handled more cases and achieved a **47% increase in extended representation cases**. On average, these cases require 18 hours of attorney time to complete. This accomplishment is significant, as it increases access to justice and provides better outcomes for our clients. It is in part due to the **launch of the Miami Dade Eviction Diversion Project**, a collaboration with other legal providers and community partners, as well as a substantial increase in the number of staff attorneys and paralegals. Although housing instability cases continue to represent most of our work, consistent with our strategic plan, we further developed other areas of practice this year – growing the **Heirs' Property Initiative** to protect homeowners and build intergenerational wealth and advancing our **education advocacy** with a dedicated Skadden Fellow.

Increasing access to legal representation has a lasting impact in our clients' lives. The families on the cover of this report are a great example of that impact. All are former clients, and we recently reconnected with them to learn how they are doing years after receiving assistance: (clockwise) Robbie and Mimi avoided foreclosure and raised their daughter in their home; Anna accessed critical healthcare services for Nathan, which enabled her to complete nursing school; Felix obtained veterans' benefits that provided financial stability for his young and growing family, and Karls received health services that changed the trajectory of his life. For each of them, access to legal services was life changing.

In 2023, we were deeply honored that MacKenzie Scott gifted Legal Services \$1.8 million. Her foundation has donated billions to nonprofits around the country, and we are proud to have been selected in the first wave of local legal aid organizations that received an award. This gift and the incredible generosity of our local and sustaining donors better position us to continue our growth and retain our incredibly talented staff. Our advocacy, growth, and impact are possible only because of the financial support we receive.

It was an incredible year, and our success is not the result of a single decision, person, or moment but the collective result of a **dedicated and innovative staff** that is committed to our mission, an **outstanding Board of Directors and Leaders**Council whose vision moves us forward, and a **community that both relies on and invests in us**.





Removing Legal Barriers to Healthcare Access & Critical Benefits



Protecting Student's Due Process Rights in School Discipline

A high school junior and her mom sought our assistance when she was expelled from her high school. A model student with good grades and extensive extracurricular involvement, she had never been in trouble before. She made a mistake and was immediately expelled for the remainder of her junior year and the following year. Legal Services filed an appeal and was successful in reducing the expulsion by half a year, allowing her to finish her senior year in her home school. This ensures that she continues to stay on the right path, graduates from high school, and excels in her post-secondary goals.



Financial Stability & Maximum Benefits for Army Veteran

A 50-year-old veteran, who was honorably discharged from the Army after four years of service sought our assistance with increasing his Veteran Affairs (VA) benefits. He had a 70% service-connected disability rating for various physical conditions. We filed a detailed claim requesting an increase and adding new claims for his major depressive disorder with anxiety distress as well as for his right hip condition. Subsequently, the **VA increased the disability rating for his physical**



condition. Additionally, the VA granted service connection for his mental disorder as 70% disabling. Because of our advocacy, his VA disability compensation more than doubled – it increased from 70% (\$1,716/month) to 100% (\$3,737/month) – and he was also awarded \$7,026 in backpay. By maximizing his VA disability rating, we ensured this veteran receives the healthcare and benefits he rightfully earned.



Promoting Health Equity Through Medical-Legal Partnership

In his late 50s and with no medical insurance, our client had multiple hospital admissions and visits to the emergency room over the years because he lacked access to ongoing treatment for a myriad of health conditions. After being denied Medicaid several times, his hospital referred him through our Medical-Legal Partnership for help. We successfully appealed the Medicaid denial, which guaranteed him ongoing health coverage and provided retroactive coverage for seven months to ensure his medical bills for that period were paid. Additionally, we assisted with his claim for disability benefits, providing him with a vital source of income. Thanks to our advocacy, our client obtained access to healthcare and disability benefits; both of which will significantly contribute to his health and well-being. Recently, he finally had cataract surgery he desperately needed to help improve his vision and quality of life.

Saved Senior Thousands of Dollars on Past Due Income Tax Debt

An elderly taxpayer came to Legal Services with a 2020 balance due of \$7,000. Even though she is on a fixed income of Social Security and living close to the federal poverty line, the IRS pressured her into an installment agreement of \$100 per month. This is the lowest installment amount the IRS said it could accept. She tried to make a few payments, but she was unable to pay the IRS and her basic living expenses.



We investigated the case and determined that the taxpayer's 2020 tax return was poorly prepared. With the help of a volunteer CPA, we prepared a 2020 amended tax return showing that the taxpayer did not owe \$7,000. In fact, she was due a refund of \$600. After waiting a year for the IRS to process the amended return, we referred the case to the Taxpayer Advocate Service to ask the IRS to expedite processing. The IRS ultimately issued a refund of \$678. Not only was the taxpayer delighted to have a few hundred dollars refunded, but she was very relieved to have the tax burden lifted.

Keeping Families in Their Homes & Safeguarding Tenants' Rights

Tenants' Rights Unit Achieves Systemic Changes for Public Housing & Section 8 Tenants



In 2023, for the first time since the COVID-19 pandemic, Miami-Dade County resumed filing evictions against public housing tenants who were behind on rent. During the pandemic, the U.S. Department of Housing and Urban Development mandated that public housing authorities provide 30-day notice before filing an eviction. However, when the County resumed evictions, it did not comply with this new requirement. **After we challenged the County's notices, they changed their practice and dismissed the evictions they had erroneously filed.** Because of Legal Services' advocacy, all public housing tenants are now receiving a 30-day notice to pay before an eviction is filed.

The Tenants' Rights unit also **submitted detailed comments to the County about their local policies impacting our clients** in public housing and the Section 8 voucher program. The County adopted several of our recommendations. The highlights include:

- 1. Disabled tenants who need a reasonable accommodation under the Fair Housing Act will now be able to provide other verification documents and are no longer limited to providing documentation from a doctor;
- 2. The County will now be required to reach out to applicants by phone and email before they remove an application from the waiting list; and
- 3. The County agreed to simplify the process for public housing residents to obtain a rent adjustment when their income decreases.

Additionally, Legal Services and community partners successfully advocated for policy changes, which will provide more time for a Section 8 tenant to find housing before their voucher expires – a critical change in this difficult housing market. These increased safeguards will provide more stability to tenants and keep more Miamians in their homes.

Protecting Tenant from Source of Income Discrimination

During COVID, our client could no longer work to make ends meet and fell behind on her rent. She and her two children were protected from eviction by the CDC moratorium, so she applied for the Emergency Rental Assistance Program to help pay her past due rent. Miami-Dade County approved the rental assistance, but her landlord refused to accept it.

Miami-Dade County law prohibits landlords from discriminating against tenants based upon their lawful source of income, so we filed an administrative complaint with the Commission on Human Rights. Last summer, the **Commission issued a probable cause determination finding that the landlord discriminated against our client**. Shortly thereafter, the landlord and our client reached a **settlement agreement**, which waived past due rent and compensated our client for her damages. We believe this to be the first case in Miami-Dade County where the Commission found a landlord discriminated against a tenant by refusing to accept the tenant's rental assistance and know it will be useful to assist other tenants who use rental assistance to avoid eviction.

Favorable Settlement for Keys Residents Leads to Nearly \$500,000 in Rent Refunds

In 2017, a 55+ mobile home community located in Marathon raised lot rents by nearly 20% while many residents are on a fixed income. Florida law prohibits unreasonable rent increases in mobile home parks. After facing this increase at a time when the Consumer Price Index (CPI) rose by only 2.5%, Legal Services helped the Homeowners' Association (HOA) challenge the increase. When negotiations failed, we filed a lawsuit challenging the unreasonable rent increase. In 2018, the park once again raised rents by 10%, and we filed a



second lawsuit. After several years of litigation, including two appeals where the HOA prevailed at the Third District Court of Appeal, in June 2023, the HOA and the park reached a settlement agreement. **Rents will stay at current levels through April 2028** (as long as CPI remains below 5%). HOA members also received a **rent refund of approximately \$150,000**.

In addition to the rent credits, the park agreed to make community improvements. In total, the settlement agreement provides rent refunds of over \$450,000 and will prevent seniors on fixed incomes from being displaced. At points during the litigation, we received pro bono support from Bilzin Sumberg and Kopelowitz, Ostrow, Ferguson, Weiselberg, Gilbert.

Defending Consumers in Foreclosure & Heirs' Property

This past year Legal Services defended consumers from improper bank and wage garnishments, advocated for the rights of consumers to obtain a fresh start from crippling debt in bankruptcy proceedings, and defended victims of ID theft against unwarranted debt collection lawsuits. Protecting homeownership is at the center of our work.





Protection from Foreclosure An elderly woman facing a reverse mortgage foreclosure for non-payment of taxes and insurance sought our assistance. We defended her on the grounds that the mortgage servicer refused to disburse insurance funds needed to make repairs to her roof and maintain the insurance. During litigation, we encouraged her to apply for pandemic-related mortgage assistance funds. Ultimately, her application was approved, the funds were disbursed to the mortgage servicer and the foreclosure case was dismissed. As a result, her home was saved from foreclosure.

In partnership with Fannie Mae, the Housing Assistance Council **December 2023 Report cites "the** homeownership gap between White households (73%) and Black households (44%) is the highest it has been in ten years."

Protection for the Next Generation The Heirs' Property Initiative was launched to assist existing homeowners with basic estate planning focused on securing the intergenerational transfer of their home. This initiative assisted an elderly, disabled veteran in one of Miami's historically Black neighborhoods. With our help he left his home to his sister through a "Lady Bird Deed," which provides for the transfer of one's home to one or more designated beneficiaries upon the homeowner's death, without the need for probate. We prepared similar deeds and wills for other homeowners. We are also currently handling complex cases seeking to remediate heirs' property with the goal of obtaining clear title for our clients' family homes.

Equity and Economic Development

Supporting Small Businesses & Nonprofits

The Community Economic Development Unit (CED) provides corporate and real estate legal assistance to small businesses and local nonprofits.

Highlights:

- Represented nonprofits in several multi-million-dollar transactions to build affordable housing in our community.
- Attorneys provided counsel on critical nonprofit **governance matters**. Whether it was reviewing an agreement with a well-known artist to paint a mural, or a commercial lease, construction-related agreements, or agreements with subgrant recipients, or guiding a nonprofit through an executive transition, CED attorneys made certain that our clients' interests were protected. Without our help, these nonprofits would have either forgone legal representation or curtailed vital community services.
- Provided small business start-up consultations and represented small businesses in contract drafting and commercial lease transactions.







Assist Nonprofit in Closing Loan to Develop Affordable Housing & Maximize Impact

CED closed a \$1 Million line of credit facility for Neighborhood Housing Services of South Florida (NHSSF) and its real estate development subsidiary. Both entities provide housing and mortgage services to local low-income families. The credit facility will provide them additional resources to acquire property to build and rehabilitate affordable singlefamily housing in our community.

In addition, we negotiated general contractor and home inspector agreements for NHSSF's weatherization contracts with Miami-Dade County and FPL where NHSSF facilitates weatherization services for low-income homeowners, including new insulation, air-conditioning, and other appliances to increase energy efficiency.

Honoring Our Pro Bono Partners

Advancing Justice for Elders: \$175,000 Settlement for Woman Wrongfully Evicted from Her Home

In a heartening victory for justice, Barakat + Bossa secured a settlement of \$175,000 in a pro bono case involving an elderly woman who faced wrongful eviction from her cherished family home. The unsettling story of murky title disputes and investor tactics found a positive resolution, highlighting the crucial role of legal advocacy in safeguarding vulnerable individuals.

The client, in her 70s and battling several health challenges, inherited her family home from her parents. Years later, an investor seemingly acquired the property, leading to her eviction. Giacomo Bossa is a specialist in business litigation and complex real estate law, so Barakat + Bossa took on the case to ensure justice prevailed. The pro bono attorney filed a Quiet Title and an elderly abuse lawsuit to establish her rightful ownership against the initial title holder. The result was a \$175,000 settlement that is now providing her with additional support as she navigates assisted living.

Bossa emphasized, "Our victory is more than financial. It's about restoring dignity and quality of life to a person who didn't deserve such distress. We must always advocate for our elderly population who too often bear the brunt of such situations."






